Joint Society Technical Meetings

Professional Development Requirements— Now the Law in PA and NJ

Professional engineers, land surveyors, and geologists in Pennsylvania are now required to obtain 24 hours of continuing education to renew their licenses in 2011. This is effective as of October 1, 2009.

Pennsylvania passed Act 25 in early May, which formalizes the continuing education requirement for licensure. This replaces the previous act, for which the State Board of Professional Engineers, Land Surveyors and Geologists had developed draft regulations.

In spite of an email from the state Board that indicated otherwise, continuing education will indeed cover the current licensure period (extending back to October 1, 2009). The information contained in that email was based on the previous act; the new act does not provide that level of discretion to the Board.

Any eligible coursework taken since October 1 can be counted toward the current two-year period. Additionally, there will be a six-month grace period



(until April 2012) for license holders to obtain the required 24 professional development hours (pdh's) if they have not already begun to do so or will not be able to acquire the full amount by the renewal date (October 2011).

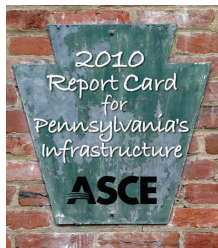

Legislative Day / ASCE Infrastructure Report Card Unveiled

The Engineers' Club joined the four Pennsylvania Sections of the American Society of Civil Engineers (ASCE), the Pennsylvania Society of Professional Engineers (PSPE), and the American Council of Engineering Companies of Pennsylvania (ACEC/PA) for the fourth

annual Legislative Day on May 24. Over 80 attendees from around the state participated and visited over 100 legislators to discuss the 2010 ASCE Infrastructure Report Card for Pennsylvania and transportation funding needs. Attendees were briefed by State Senator John Rafferty before going off to their appointments with legislators.



The ASCE Report Card was released in a ceremony in the State Capitol at 8:00 am that day and at local events around the state later in the day. The Report Card assesses twelve specific areas of infrastructure conditions. The highest grade was B for Rail, while six of the twelve areas were D- or D+.

The Harrisburg event concluded with a well-attended legislative reception sponsored by ACEC/PA.

Locally, the Report Card was unveiled by the ASCE Philadelphia Section at a ceremony at Dilworth Plaza on the west side of City Hall at 12 Noon, with local media outlets providing coverage and close to 200 attendees there to get copies of the

Report Card in bright-red tote bags.

While the Report Card grades all infrastructure conditions, the particular focus of the Legislative Day efforts was transportation facilities. With the prospect of reduced funding for roads, bridges, mass transit, and other transportation components, in spite of the growing needs, and no new resources in sight, our voices need to be heard, both as engineers and state residents. Transportation is an issue that affects all of us in some fashion. We appreciate the efforts of those who planned, orchestrated and attended these functions, and we encourage you to contact your elected representatives to express the importance of continued long-range transportation and infrastructure funding.
